A quorum of State Water Board members may be present at the scoping meeting. No action will be taken by the State Water Board at the scoping meeting.


#### AVAILABILITY OF THE SCOPING DOCUMENT

### TRANSPORTATION, PARKING, AND ACCESSIBILITY

Hourly and valet parking are available at the Pier 3 parking lot. The Pier 3 lot is accessed through the Pier 3 building entrance on the east side of the Embarcadero. This lot is located on the pier deck; adjacent to the ferryboat Santa Rosa. Additional parking is available in the Golden Gateway Garage, which is bounded by Washington, Clay, Drumm, and Battery Streets. The entrance is on Clay St. between Battery and Front Streets. Metered street parking is available on the Embarcadero, Washington, and Folsom & Drumm Streets.

<u>Alameda/Oakland Ferry</u>: Daily year-round service between Oakland's Jack London Square, Alameda Main Street, the San Francisco Ferry Building, and San Francisco's Fisherman's Wharf area is available. <u>BART</u>: Embarcadero Station is in walking distance from the Ferry Building: Embarcadero Station 298 Market Street San Francisco, CA 94105

Both entrances lead to the Bayside conference rooms. Accessible public restrooms, drinking fountains, payphone, and TTY are on the first floor near the main entrance.
